**Travel Waiver**

**I. Introduction**

**II. Scope of Agreement**

The Traveler acknowledges that they have read, understood, and agree to comply with the terms and conditions outlined in this Agreement.

**III. Assumption of Risks**

The Traveler acknowledges and understands that travel inherently involves certain risks, including but not limited to:

- Transportation accidents
- Illness or injury
- Property loss or damage
- Natural disasters or emergencies

The Traveler agrees that **Mah Society of Edmonton and Directors** shall not be held liable for any loss, damage, or injury incurred during travel, except in cases of gross negligence or willful misconduct on the part of the Agency.

**IV. Health and Safety**

#### **VI. Indemnification**

The Traveler agrees to indemnify and hold harmless **Mah Society of Edmonton and its Directors** from any loss, liability, damage, or cost, including attorney fees, arising out of or related to the Traveler's participation in the travel services or the violation of any law or the rights of a third party

#### **VII. Cancellation and Refunds**
